




Indian Music industry

- The Indian music industry was valued at **around 19 billion Indian rupees at the end of 2021** and is **estimated to reach 28 billion rupees by the end of 2024**.
- The sector is estimated to grow at a compound annual rate of 15 percent .

Categories of Indian Industry revenue




■ Digital ■ Synchronization ■ Performance rights ■ Physical

The music industry revenue is broken down into 4 broad categories:

- ♪ **Digital**, which includes streaming and all other kinds of digital music;
- ♪ **Synchronisation** or “sync” for short, which is a music licence granted by the holder of the copyright of a particular composition, allowing the licensee to synchronise music with some kind of visual media output;
- ♪ **Performance rights**: songwriters, composers, and music publishers have the exclusive right to play their music publicly and authorise others to do so under the copyright law;
- ♪ **Physical**, where you’d use media such as vinyl records, CDs and cassettes to listen to music.
